Sub:- Upgradation of school from Secondary to Senior Secondary level with effect from Academic Session 1998-99 (with out aid) in Commerce and Humanities.

Madam,

With reference to your application on the subject cited above, I am directed to convey the approval of the Director of Education, Delhi for the upgradation of the existing Secondary school to Senior Secondary level w.e.f. 1998-99 session subject to the fulfilment of the following terms and conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act and Rules, 1973 as well as the instructions issued from time to time.
2. That the school shall admit the students without any discrimination of caste and creed.
3. That the school will meet the additional liability of Senior Secondary classes by appointing more staff as per the norms of the department and subjectwise PGTs shall be appointed and Govt. nominee shall also be invited at the time of selection of the teachers.
4. That the proper Library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per students and more approved standard books for Senior classes and reference books for teachers shall be added.
5. That more sport material for out-door games shall be purchased and made available to the students.
6. That the school shall strictly abide by the provisions of section 15(1) of the Delhi School Education and Rules 1973 and payment shall be made through crossed cheque. Bonus, LTC, Medical allowance, gratuity and pension as applicable to Govt. employees of Delhi Admn. shall be paid to the employees of the school.
7. That the enrolment of each section shall not exceed the number of students calculated @ 12 Sq ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education in each class. Number of section should not exceed the number of existing class rooms of proper size in the school and each class room, science labs and library rooms may be fitted with proper electrical appliances.

- 8. That the school not run unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the above address only.
- 9. That the school shall recruit the teachers and other employees as per recruitment rules framed under DSER, 73. Services of unqualified and over-aged staff, if any shall be dispensed with immediate effect.
- 10. That all the facilities prescribed under rule 50 and 51 of the Delhi School Education Rules, 1973 shall be made available to the students.
- 11. That the violation of any instructions/orders/conditions/rules and regulation of the Department shall lead to the withdrawal of recognition of the school.
- 12. That the school authorities should appoint required number of teachers within three months of grant of upgradation.
- 13. That the school should give an undertaking that they will not introduce Science stream without the approval of the Director of Education.

11. The Managing Committee of the school shall not increase fee in future during academic session without prior approval of the Director of Education which is a mandatory requirement under Sub-section (3) of Section 17 DSEA & R, 1973.

- 12. That all the facilities prescribed under rule 50 & 51 of the DSEA & R, 1973 shall be made available to the students.
- 13. Proof to the effect that qualified staff has been appointed as per RRs be provided for the verification of E.O.
- 14. That the arrangements for good drinking water shall be made available to all the students, as well as to the teachers & sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the local body within a month.
- 15. That the school shall comply with the norms of the CBSE for affiliation for examination purposes.
- 16. Medical facilities/leave LTC bonus, Teaching Allowances, CPF etc. be paid since recognised by the school.
- 17. Provident Fund Register be maintained, and cash-book, be complete and shown to E.O. of the Zone concerned for certification, from time to time.

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow all the provisions of Affiliation Bye-Laws- 2018, Examination Bye-Laws, circulars, guidelines, instructions and other amendments issued from time to time by the Board.
3. The School shall possess following valid mandatory documents at all times :

  - b. Recognition Certificate

4. The School shall also ensure the compliances with the Board's Bye-laws in respect of following facilities and infrastructure within 3 months and submit compliance on SARAS portal.
  1. Boundary Wall: Concrete boundary wall of not less than 6 ft. height, enclosing the school campus/site. Composite boundary walls which are partly concrete and partly grill/mesh/barbed wire below 6 feet will not be acceptable. If fencing/grill is required, then the same should be over and above 6 feet height.
  2. Ramps at the entrance(s) as well as Ramps/lifts for CWSN, to access the upper floors of the school (in case of a multistoried school) (Circular No. CBSE/AFF-05/2023 dated 06.03.2023).
  3. Separate toilets for CWSN, boys and girls on every floor (in case of multistoried schools) (Circular No. CBSE/AFF-05/2023 dated 06.03.2023).
  4. Appropriate laboratory infrastructure for Secondary School (Composite Science Lab, Mathematics Lab, Computer Lab) and for Senior Secondary School (Composite Science Lab, Mathematics Lab, Computer Lab, Physics Lab, Chemistry Lab, Biology Lab.) (Circular no. CBSE/AFF-11/2022 dated 04.10.2022)
  5. Well stocked library with adequate reading area. (Circular no. CBSE/AFF-11/2022 dated 04.10.2022)

6. Well-developed indoor and outdoor sports facilities. (Circular no. CBSE/AFF-11/2022 dated 04.10.2022)
7. Well-developed Digital Infrastructure (Circular No. CBSE/AFF-10/2023 dated 24.03.2023)
